Central Committee for Holding Myanmar Gems Emporium
The Information on 58th Myanmar Gems Emporium, 2023

1. The significant 58th Myanmar Gems Emporium, under the supervision of the Ministry of Natural Resources and Environmental Conservation, will be held on March 17 to 23, 2023 at Maniyadana Jade Hall in Nay Pyi Taw.
2. Genuine Myanmar Pearl lots will be sold in US Dollars (USD) but payment for pearl lots shall be made in US Dollars (USD) or Euro (EUR) or Chinese Yuan (RMB) or Thai Baht (THB) which is an equivalent amount in US Dollars (USD).
3. Gems and Jade lots will be sold in Euro (EUR) currency at the Emporium. Payment for gems and jade lots shall be made in Euro (EUR) or US Dollars (USD) or Chinese Yuan (RMB) which is an equivalent amount in Euro (EUR).
4. Pearl, gems and jade lots will be put up for sale through open tender system and specifying reserve prices are as follows:-

Sr.	Type of Lots	Reserve Price
(a)	Pearl	US\$ 1,000 and above
(b)	Gems	€ 5,00 and above
(c)	Rough Jade	€ 5,000 and above
(d)	Finished Jade Products	€ 1,000 and above

5. Foreign visitors who are eligible for the following qualifications will be granted admission to the 58th Myanmar Gems Emporium, 2023 excluding those blacklisted for their default on payment in the previous emporiums:-

- (a) Those who requested the invitation card via the local represented companies.
- (b) Those who requested the invitation card via the Foreign Jade Associations.
- (c) Those who requested to receive the invitation card through the respective Embassies and Consulate – General.
- (d) Those Foreign visitors are permissible to make bids for the lots up to the value of the minimum amount of deposit to be paid by the type of lots and

the amount permitted to bid are as follows:-

(b)	Gems	€ 2,000	€ 20,000
(c)	Jade	€ 20,000	€ 200,000

6. Making bids for lots more than the permitted limit is required to make additional deposit (10% of its value) to the Central Committee of Emporium (Deposit) Account opened at Myanmar Economic Bank (Nay Pyi Taw). Deposit must be made by deadline as below:-

7. Starting from March 10, 2023, the process of deposit payment and ahead of issuing entrance card for foreign gems merchants will be carried out at the Maniyadana Jade Hall, Registration Office.

8. Application Forms for admission to Emporium can be downloaded and submitted via Online Preregistration System on provided Myanmar Gems Enterprise website www.mge.gov.mm ; starting from March 6, 2023.

9. The requirements to make the entrance card are as follow:-

- (a) Name, Passport and National Scrutiny Card No. (Passport Issuing Country),
- (b) Clear Photocopy of Passport,
- (c) Clear two passport photos taken within one month,
- (d) Complete contact information, (to state Phone No., Fax No., E-mail and address),
- (e) Admission fee – US\$ 100,
- (f) Every Merchant must submit the Certificate of fully vaccination.
- (g) According to the Covid-19 instructions stated by Ministry of Health, if all Merchants will be needed to test for Covid-19 by RT-PCR on their arrival

in Myanmar, the Medical cost and Health insurance premium will be borne by oneself.

10. Foreign gems merchants who will attend the Emporium are not allowed to wear indecent outfits such as shorts, singlet and must attend the emporium with the following specified outfits:

- (a) Man – Western–Suit (Exhibition Opening Day), collared shirt and trouser (Other Days)
- (b) Lady – Mari, Midi skirt / trouser and blouse that is not crop top / sleeveless/ too low at the neckline

11. The delegation process must be completed at Administrative Work Committee during the Emporium in order to carry out the matters of making payment and taking the lot(s) out by agent on behalf of buyer after purchasing the lots.

12. Buyers, themselves or their authorized representatives shall settle payment for the purchases within (90) days deadline as prescribed by the Sales Agreement. In case of the buyer's failure to purchase, action will be taken in accordance with the rule, regulation and stipulation concerned.

13. Shipment of fully paid purchase to the buyer is made under the EXW (EX Works) System. Purchase will be timely dispatched once the buyer, himself or his authorized representative has made full payment for the purchase. Emporium Central Committee will be responsible for loading the merchandise onto the Transportation Vehicles from the Emporium Hall while company will be held liable for the remaining processes on behalf of the buyer.
