1. The Ministry of Energy of the Republic of the Union of Myanmar hereby announces Invitation of Sealed Bids for Petroleum Operations to be conducted in Myanmar Htaukshabin-Kanni Oil Field on Improved Petroleum Recovery (IPR) basis.

All interested parties are cordially invited to submit "the Letter of Expression of Interest", together with Company's Article of Association (AOA), Memorandum of Association (MOA) or Constitution of Company, Certificate of Incorporation, last (3) Years Annual Report and last (3) Years Financial Statement (or) Financial Report, Detail Track Record and related documents, **"Myanmar Htaukshabin-Kanni Oil Field Bidding Round -2022"**, to the following address not later than (12:00) noon at the date of 17 June 2022:-

The petroleum operations shall be conducted on improved petroleum recovery basis and the party(s), who desire to enter into the Improved Petroleum Recovery Contract (IPR) with the Myanmar Oil and Gas Enterprise (MOGE) shall have technical competency, financial capability, experience, expertise and technical know how to conduct petroleum exploration and development works and must have good track record.
4. The potential bidders will be pre-qualified and selected. Then the potential bidders who passed pre-qualification will be presented with General Overview of

Htaukshabin-Kanni Oil Field's data and information free of charge by Geological/ Geophysical Team of Myanma Oil and Gas Enterprise.

5. The potential bidders will be explained and provided with Standard Terms and Conditions by Oil and Gas Planning Department in order to submit proposal(s).
6. The potential bidders will have to submit the proposal(s) together with proposed Terms and Conditions.
7. The potential bidders' proposed Terms and Conditions will be assessed and the best offered Terms and Conditions will be selected for awarding.
8. If the potential bidder is foreign-owned company, such potential bidder will have to submit at least one Myanmar National owned company for cooperation.
