Announcement for Recommendation of Foreigners' Visa Extension

1. A company which applies recommendation to extend foreigners' visa must be a company whose registration period has been completed for 1 year.
2. Suspended and Struck-off companies due to failure to comply with Myanmar Companies Law (2017) will continue to accept recommendation for visa extension only after 1-year compliance.
3. Foreigners from the company who wish to obtain recommendation for visa extension must apply at least 90 to 120 days prior to their expiration. The foreigner's passport must be valid for at least 6 months.
4. In order to apply recommendation for foreigner's visa extension, the company must be able to present the following documents-
 - (a) Updated Company Extract Form,
 - (b) Evidence of company's current operations, (License/Permit/Evidence from Government Agency, Business Contract with Other Related Organization (if Any))
 - (c) Proclamation of the company's board of directors regarding the foreigner
 - (d) Company must submit tax returns or audit reports for fiscal years 2020-2021 and fiscal years 2021-2022 and fiscal years 2022-2023, or proof of prior income tax payments (if applicable),
 - (e) CV Form of the relevant foreigner including a prominent (2"x 1.5") size photograph taken within 6 months, education, experiences and permanent foreign address (domestic/local address)

 - (f) Terms of Reference (TORs)/Job description for the foreign employee's position and duties in the company,
 - (g) Employment contract and foreigner's education certificate/ qualifications
 - (h) To inform DICA in case of change of local address of the foreigner
 - (i) If a foreigner submits a second extension, evidence of his income tax payment for the periods he/ she has served must be presented.
 - (j) Number of employees in company (foreigner/citizen) including name, passport number/ national registration card number, phone number

- (k) Evidence of kinship must be attached for family members (wife/husband/son/daughter) of relevant foreigner.
- 5. Companies operating under Myanmar Investment Commission Permit/ Endorsement must apply only at MOVAS (<http://movas.dica.gov.mm/>). If you apply for an online visa extension recommendation at <https://visaonline.dica.gov.mm/>, it will not be accepted.
- 6. This announcement is effective from 14-9-2022.

(Although the Directorate of Investment and Company Administration conducts necessary verification on the submitted visa case, the application can be rejected unless it conforms with the existing policies.)

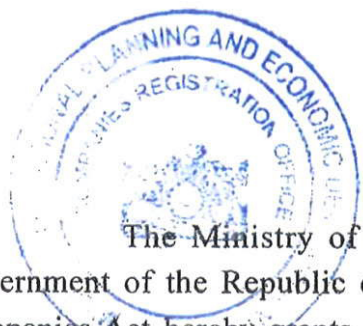

- Period of stay in Myanmar restricted to 70 Days from date of arrival. It can be extended.

DOCUMENTS REQUIRED FOR BUSINESS VISA (MJEV)

1. Appointment letter (online Q number)
2. ONE copy of duly-filled Business VISA application form. Every set of application form has to be duly signed by the applicant. False Signature may result in non-acceptance at the VISA counter
3. TWO recent photos of 1.5 x 2 inches with white color background (Scanned photos are not allowed, without any Glasses & photo must be taken in 6 month time)
4. Passport with sufficient VISA pages and its validity should cover the validity of the VISA applied
5. Applicant's Name Card/ Business Card
6. Photo copy of the first page of passport with the applicant's photo shown
7. A photocopy of IC/ PR (with Re-Entry Form-7)/ EP/ Student Pass (Both sides)
8. Birth Certificate is required to submit if the applicant is under 15 years old
9. An original invitation letter to you from a registered company in Myanmar ***attached with company registration letter***
10. An original recommendation letter to you from a registered company in Singapore
11. VISA fees S\$ 350 (For MJEV 3months) , S\$ 700 (For MJEV 6months), S\$ 1050 (For MJEV 1 Year)
12. Applicants may be asked to provide other documents if and when necessary

TIME

- Visa application submission : Monday to Friday, From 9:00 am to 12:00 pm (noon)
- Visa Collection : Monday to Friday, From 3:00 pm to 4:00 pm
- Visa Processing Time : 1 working day in most cases
- We strongly recommend that visa applicants should not purchase flight tickets or make unchangeable travel plan before obtaining visa

NOTES

1. On the appointment date, please come to Myanmar Embassy at 9:00 am.
2. Make sure you bring all required documents listed above. Your application may not be accepted if you cannot present all required documents.
3. If you do not have long term stay permit in Singapore, your application will not be accepted.
4. When you are arrived Embassy, please wait for your queue number. Once your queue number is called, proceed to visa application counter and submit your application with required documents.
5. If your application is accepted, you will pay visa fees and visa processing fees. Authorized staff will issue a receipt and your application submission process will be completed.
6. You can collect your passport on the same working day between 3:00 pm and 4:00 pm.
